In order to insure that each Diocesan Delegate is subject to the appropriate control of the respective Ordinary, every delegate shall be a priest of that Archdiocese or Diocese, or an employee of the Archdiocese or Diocese, or an employee of a religious or not-for-profit entity controlled by the Archdiocese or Diocese; (2) be an individual who demonstrates respect for and belief in the teachings of the Church regarding the significance of Christian burial and the sacredness of Catholic cemeteries; and (3) not be an officer, agent or employee or otherwise subject to the direction of any entity, except one sponsored and controlled by the Archdiocese or Diocese he or she shall represent. (Bylaws of the Catholic Cemetery Conference, Article IV., Section 2., A.)
