Scholarship Opportunity 74th Anniversary Convention & Exposition

Purpose

This Catholic Cemetery Conference Scholarship helps Catholic cemeterians currently employed by Catholic Cemeteries. The Scholarship is intended to help pay registration costs related to attendance at the CCC 74th Anniversary Convention & Exposition.

Eligibility

Any employee of an affiliated Catholic Cemetery that is a member of the Conference, is eligible to apply for a CCC Scholarship, provided the applicant has been continuously employed by the respective Catholic Cemetery for at least one year. **Applications must be approved by the applicant's employer.**

Scholarships

Funding for Scholarships is provided by Supplier Members as a form of support and sponsorship.

The individual scholarships will be based on demonstrated need, as well as what changes the individual hopes to gain from attendance. Scholarships will be awarded each year one month prior to the annual convention as funding permits.

Scholarship Opportunity 74th Anniversary Convention & Exposition

Criteria

- Catholic Cemetery Conference (CCC) Scholarships are available to any employee of an affiliated Catholic Cemetery that is a member of the Conference, who has been employed at least one year at time of application.
- Scholarships are intended to help pay costs directly related to the applicant's continuing education.
- Applications must be approved by the applicant's employer
- The amount of each scholarship will be for full registration. *(Not including housing or travel expenses)*
- Scholarships will be available in any given year where funding is provided and will be determined by the CCC Education Committee.
- No applicant shall receive more than two scholarships per lifetime from any CCC Scholarship program.
- No applicant may apply for a second scholarship without providing proof of successful completion of attendance for which the first scholarship was awarded.
- Applications for the year 2023 scholarship must be received at the CCC Office by August 30, 2023.
- Scholarship will be reimbursed to applicant only upon proof of registration payment by applicant to CCC.
- Any tax liabilities are the sole responsibility of the scholarship recipient.
- Limit 2 (two) Applicants per Diocese, no guarantee of award.
- All Scholarship recipients are required to write a "What I Learned" article for publication in the monthly publication.
